SERVICE DELIVERY & CONSUMER/CLIENT CARE: SERVICE AGREEMENT

Ever wonder what goes into the process of initiating home care and/or home health care services? A very important step in that process is the service agreement.

CAS Home Health Care & Home Care Agency enters into a service agreement with the consumer/client/client's representative before the initiation of any home care services to the consumer/client. The purpose of this policy is to clearly define the service(s) to be provided and the terms and conditions for receiving service(s) in a written agreement/contract.

When an individual is accepted for service, a written Service Agreement shall be signed and dated by the consumer/client/client's representative and the Agency. A copy of the signed agreement shall be given to the consumer/client and the original copy of the signed agreement shall be maintained in the consumer/client's file at the Agency's office (Intake Coordinator).

The written Service Agreement may include, but not be limited to, the following items, which may be located in the agreement body, in supporting statements, in documents or in attachments:

- a. street address and mailing address of the Agency;
- b. consumer/client/client's representative's consent to receive services, authorized by signing the Service Agreement;
- c. date of the request/referral for service;
- d. a description of, the frequency and the duration (if known) of the services to be provided;
- e. date services shall commence;
- f. rights and responsibilities of the consumer/client;
- g. procedure and contact numbers for contacting the Director of Nursing (DON), Assistant Director of Nursing (ADON) or designee during all hours wherein services are provided;

SERVICE DELIVERY & CONSUMER/CLIENT CARE: ON-CALL SERVICES

CAS Home Health Care & CAS Home Care has established that the Agency shall have qualified and competent on call Agency Representatives available to accept and respond to incoming calls for assistance with the service/care needs of its clients/potential clients. On-call services strive to always meet consumers/clients' service and care needs during office closures, on-call staffing schedule shall be developed. On-call support shall be available 24-7 during all periods the Agency office is closed including weekdays, weekends, and statutory holidays. Personnel will be assigned to on-call duty on a rotational basis: On-call support shall be provided for:

1. Administrative support from a member of the Management Team;
2. Clinical Support by a Registered Nurse;
3. Personal Care Support by a Direct Care Worker.

The purpose of this policy is to establish an on-call system, which provides access to Agency Representative(s) when the Agency office is closed to ensure: client services and care can be adequately supported. In addition, to ensure that effective responses and resolutions can be provided to urgent matters; and a consistent approach is established for managing on-call and call-out services.

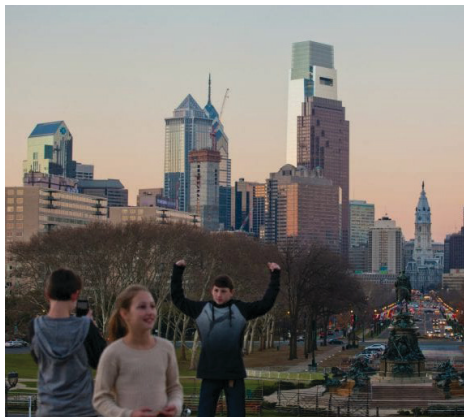

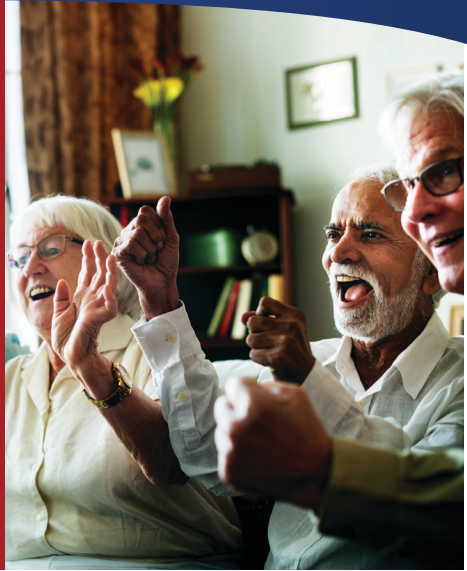
HOME CARE VS NURSING HOMES

to choose their caregiver and make changes as services are provided. Another advantage of home care, arguably most important, is that it encourages independence. If patients require limited assistance with specific tasks, a move to a nursing home could force them to give up their cherished independence sooner than necessary which could be a shocking and disorienting experience.

Nursing Homes

A nursing home, also referred to as a Skilled Nursing Facility, is a long-term care services facility that provides housing to your loved one, in addition to housekeeping and nursing services. They usually offer around-the-clock medical care for consistent support. Nursing homes offer residents outdoor spaces, visiting rooms, dining

facilities, and recreation spaces to make residential life more enjoyable. Majority, if not all, of these spaces are shared, however. Depending on your loved one, this may be a pro or a con. Assisted living facilities tend to be more expensive especially when amenities that may not be need could be included.

Ultimately, depending on your loved one's needs, an assisted living facility may be favorable or vice versa. Typically, however, home care has become the more popular option due to its numerous advantages.
